Accordingly the lease hold rights have been allotted to him vide this office letter No. Shop No.11/RBS/1182 dated 31/07/2024 for a period of 3 years w.e.f. 30/08/2024 to 29/07/2027. However, after taking over the possession, the lessee failed to pay the monthly fees and GST even for a single month. Despite repeated requests from the tax/bill collector, the lessee neither completed the signing of the lease agreement nor made any payments. In accordance with the tender terms and condition No. 10, lease hold rights allotted to Mr. Vasim Noormohammed Megriwale in respect of the ibid shop may be terminated with the forfeiture of permanent security deposit of Rs. 40,200/-. Despite repeated requests from the tax/bill collector, the lessee neither completed the signing of the lease agreement nor made any payments. Furthermore, the lessee has not signed the lease agreement till date and has also kept the shop closed. Therefore as per tender terms and condition No. 10, in the event of the successful tenderer allowing to accumulate the monthly fees for 3 consecutive months, the lessor has the authority to summarily terminate the agreement and evict the lessee forthwith with a forfeiture of entire deposit of the lessee.

In view of the above and in accordance with the tender terms and condition No. 10, lease hold rights allotted to Mrs. Naziya Vasim Megriwale in respect of the ibid shop may be terminated with the forfeiture of permanent security deposit of Rs. 43,200/-. Further, name of the lessee viz., Mrs. Naziya Vasim Megriwale may be blacklisted for 3 years and also an application before the judicial magistrate under Section 324 of the Cantonments Act 2006 may be filed to recover the outstanding dues. Board may consider and resolve accordingly.

Regarding levying of hawker/vendor fees in respect of hawkers selling egg, fish chicken items and various biryanis in hawker zone of Belgaum Cantonment Area.

The Cantonment Board is currently collecting hawker/vendor fees from various hawkers and vendors under the following categories and rates:-

However, it has been observed that many hawkers have erected temporary structures in prominent areas such as Bewoor Road, Station Road, P. B. Road, Sanchayani Circle, Near Postman Circle, and the Dargah near Station Road. These hawkers are selling egg items, fish items, chicken items, and various types of biryanis.

At present, this office is collecting a hawker/vendor fee of Rs.50/- per day from these vendors. However, it is noticed that the income generated by these vendors is significantly higher compared to the income earned by vendors categorized under S.No. 3. Thus, it is proposed that a higher fee be levied for these vendors.

In view of the above, it is proposed to create a <u>4th category</u> for hawkers/vendors for selling egg items, fish items, chicken items and various types of biryani. Approximately 20 to 25 hawkers/vendors fall under this category. The proposed revision aims to establish a fair and balanced fee structure that is more aligned with the revenue potential of these vendors. By doing so, it ensures equity among different categories of hawkers and vendors, preventing any undue burden on lower-revenue segments while capturing the potential of higher-revenue vendors. The Hawker/Vendor fee for 4th category is <u>proposed @Rs.100/- per day</u>. Board may consider and resolve accordingly.

RESOLUTION No. 14

The matter was discussed at length, and the Board unanimously agreed that the fees for selling high-demand foods such as Egg and chicken items should be higher, as these items generate significantly more income compared to those listed under Sl. No. 01 to 03 in the agenda side.

Accordingly, the Board resolved to introduce a fourth category with a fixed fee of Rs.100 per day, based on the type of structure and the hawker's business.

The Board vide CBR No. 52 dated 15.07.2024 has appointed Smt. Marielyn Correa as an Educational Auditor for all three schools of the Cantonment Board, Belgaum. The Educational Auditor has submitted an assessment report dated 08.01.2025 regarding the performance of the HMs and School Teachers. According to the report, the performance of the HMs and Teachers is hereby put up for the consideration of the Board.

The Academic Auditor's Assessment Reports are placed on the table.

RESOLUTION No. 17

Considered and noted. The Chief Executive Officer explained that the Educational Auditor has assessed the Headmasters (HMs) and Assistant Teachers for the academic year, taking into consideration various categories such as lesson planning and preparation, subject knowledge and expertise, teaching delivery, classroom management, student engagement, and participation etc. The report categorizes them as Below Average, Average, Good/ Very Good/ Excellent.

In view of the above, the CEO suggested to the Board that this report should be considered as a parameter for future promotions and increments of HMs and teachers. Additionally, teachers rated as Below Average & Average shall be issued a letter regarding the importance of improvement in their performance.

Regarding black listing of the firm Bagalkoti Advertisers, Belgaum for non-payment of outstanding dues in respect of hoardings erected in Belgaum Cantonment Area.

The Cantonment Board vide CBR No. 19 dated 29/03/2016, approved the highest bid quoted

by Bagalkoti Advertisers, Belgaum for 04 hoardings at various locations. The hoardings were allotted to Bagalkoti Advertisers for a period of two years, from 01/04/2016 to 31/03/2018. The details of hoardings are as under:-

After expiry of contract period i.e, 31/03/2018, the contractor has been directed to clear the outstanding dues and handover the hoardings. Total 27 notices has been served to him w.e.f. 28/03/2018 to 19/04/2024. But he has failed to clear the dues. The last reminder was issued to him vide this office letter No. 10/LAND/ADV/1868 dated 10/10/2024 informing him to clear the outstanding dues of Rs.4,09,687/- towards hoarding licence fees & other charges. Further, if he fails to clear the dues, his firm will be blacklisted and action will be taken under Section 324 to recover the dues.

The contractor, in his response, claimed that no hoardings or advertisements were placed at the allotted sites and requested further examination of the matter. This office, via letter No. 10/LAND/ADV/2627 dated 09/01/2025, provided an appropriate response, stating that as per the CBR, four hoardings were duly allotted to Bagalkoti Advertisers. However, during an inspection conducted in 2018-19, it was observed that only one hoarding, measuring 600 sq. ft., was located at the junction of Khanapur Road and South Telegraph Road (Cantonment Board Office Compound Wall).

Subsequently, demand notices were issued to him for single hoarding of 600 sq. ft. and bills were regularly issued from 2019 to 15/03/2024. During this period, the contractor neither raised any objection to the issued bills nor provided any information regarding the non-existence or non-display of advertisements on the said hoarding. He was further informed that the bills raised by this office are correct and accordingly he is liable to pay an outstanding amount of ₹4,09,687/- upto the period ending 19/03/2024. And further he has been finally called upon to clear the outstanding dues of Rs.4,09,687/- towards advertisement fees, damage charges, and GST, within a period of 15 days from receipt thereof, failing compliance, the name/firm name will be blacklisted and action under Section 324 of the Cantonments Act 2006 will initiated against him to recover the dues. Details of outstanding dues are as under :-

Board may consider and resolve accordingly.

After conducting Sanitary round by the above officials, it has been observed that the above mentioned eateries has not maintained hygiene standards. Accordingly, the Show Cause Notices have been issued and a fine has been collected.

Sanitary Inspector's report is placed on the table.

RESOLUTION No. 19

The Member Secretary informed the Board that, as per the sanitary inspection, the eateries listed in the agenda are in extremely poor in maintaining hygiene condition and requires a strict action.

After a detailed discussion, the Board resolved that a notice should be issued to all eateries mentioned in the agenda side, directing them to improve their hygiene standards in accordance with food safety rules and regulations. Afterwards, an inspection shall be conducted, and if no improvements were found, the action will be initiated for ceiling the premises as per the provisions of the Cantonments Act, 2006.

As per MoD Policy u/ref 1 & 2, the mode of application and authority for execution of agreement for different categories and the charges to be levied are as follows: -

- For residential pockets and others area in cantonments (other than A-1 land), the applicant/PNG Company/City Gas Distribution Company will have to apply to the Chief Executive officer of Cantonment Board.
- In areas where both Class A-1 land and other Class of defence land is involves in Cantonment areas for laying of PNG Infrastructure, the applicant/PNG Company will have to apply to the CEO of the Cantonment Board. However, Cantonment Board will have to obtain NOC from the Station Hqs for laying of PNG line on A-1 land before the application is processed for sanction.
- For Category I, the license agreement will be signed by the Defence Estates Officer while for Category II & III, the license will be issued by Cantonment Board as per provision of the Cantonment Act, 2006.
- Principal Director, Defence Estates of the Command will be the sanctioning Authority for grant of license for use of Defence land for laying of PNG infrastructure/Pipeline.
- Permission to use Defence land to Government owned PNG companies for laying underground pipeline and valve chamber will be accorded at an annual license fee @ Rs. 1/- per running meter. Wherever the City Gas Distribution Company authorized by PNGRB is a non-Government company/Private companies annual license fee will be fixed at the rate of 2.5% of value of land based on STR/MNS/circle rates, as the case may be.

As per MoD Policy u/ref 1 and 2, the applicant has to pay Security Deposit, License Fee and also the Road Cutting Charges as per CBR No. 21 dated 15.07.2024.

Report of Assistant Engineer and all concerned files, along with letters u/ref are placed before Board for consideration.

RESOLUTION No. 20

The matter was discussed in detail and the AE explained the Board that the pipeline to be laid in 'C' road is 1881 mtrs and area involved is 564.3 Sq.mtrs. As per the Policy dated 11.02.2025 "whenever the City Gas Distribution Company (CGD) authorized by PNGRB is a non-Government Company/Private Companies annual license fee will be fixed at the rate of 2.5% of value of land based on STR/MNS/Circle Rates, as the case may be".

The Megha City Gas Distribution Private Limited is a Pvt firm which is authorized by Petroleum and Natural Gas Regulatory Board (PNGRB) for lying of Gas Pipeline in entire Karnataka State vide Schedule dated 14.09.2025. They have been empowered to lay, build, operate or expand the city or local natural gas distribution network.

As per the policy u/ref 02 mentioned in the agenda side, the Annual License fee calculated as per 2.5% of Land Cost based on prevailing STR is Rs. 2,77,999 and as per the Policy u/ref 01 mentioned in the agenda side, the Mega Gas Company has to pay Security Deposit to Cantonment Board, Belgaum which is 5% of Land Cost amounting to Rs. 5,56,000/- as per prevailing STR.

As per report of the AE and based on CBR No. 15 dated 15.07.2024 the road cutting charges fixed is Rs. 1500 per running mtr. For road cutting of 1881 mtr, the total road cutting charges comes to Rs.28,21,500/-. This amount should be collected from the Megha City Gas Distribution Private Limited.

During the discussion, the PCB directed that after cutting of the road for installation of Gas Pipeline the same has to be restored to its original position by way of earth filling, WBM, re-carpeting etc., by the Company within 3 months from the date of completion of the project, failing which the Security Deposit shall be forfeited. The PCB further stated that, if the said Company did not carry the restoring work of roads within 3 months of completion of project, the same may be carried out by the Cantonment Board, Belgaum by utilizing the road cutting charges amount and Security Deposit amount to be paid by the Megha City Gas Distribution Private Limited.

After a detailed discussion, the Board considered and resolved to forward necessary proposal to the PD,DE, SC, Pune for approval as per the Policy in force.

Revision of the Conveyance Allowance rates.

Considered and Approved. The Chief Executive Officer explained the Board that the Operation Madat Group, Shashtri Nagar Belagavi has come forward to develop the Bhagini Nivedita Garden with the theme of Butterfly Garden and Children Garden under CSR funding. Further, the PCB directed the CEO to fix a Joint Inspection of the site since there is a proposal of construction of Army Quarters.

The Cantonment Board, Belgaum vide letter u/ref has requested the Operation Madat Group, Shashtri Nagar Belagavi to develop the vacant land at GLR SY No. 211/1 as Nursery and Agro forestry after mutual discussion, mutual agreement and maintain the said Nursery after development.

Report of Assistant Engineer and all concerned file, alongwith letter u/ref are placed before Board for consideration.

RESOLUTION No. 24

Considered & resolved to conduct a Joint Inspection of the site in question along with the Operation Madat Group for further necessary action.

AGENDA No. 25

Regarding revision of rates of property tax as required under Section 66 of the Cantonments Act 2006.

Ref : Audit Memo No. 8 dated 09-01-2020 received from the Senior Audit Officer, Defence Service, Office of the Principal Director of Audit, Pune.

During the CAG audit, the Senior Senior Audit Officer in his Audit Memo, cited under reference has mentioned that the this office has not revised the rates of the property tax since March 1992 which is a abnormal delay in revision of the rates of property tax. In their audit memo they have also given direction to give the specific reasons for non-revision of property tax for last 28 years as well as non levy of various elements such as drainage tax, education tax, tree tax etc., as levied by Municipal Corporation Belagavi. Further they have also opined that the non-revision of tax structure deprived the Cantonment Board for increase in their revenue

resources.

In reply to the said observation, this office has intimated that as per norms, Cantonment Board is required to follow the local municipal taxes rates which are prevailed in the nearby municipal corporation. Prior to 2002-03 the rate of property tax of the neighbouring city corporation was 20% of the Annual Letting Value. Therefore the rates were not increased w.e.f. 1992 as the rates of this Board was higher than the City Corporation of Belgaum i.e, 22% on the ARV of the property.

In the year, 2018-19 to make comparison of rates of property tax between the Cantt. Board and the neighboring municipal corporation, a letter No. 2/REV/75/1698 dated 31-01-2019 has been issued to the Commissioner, City Corporation Belgaum to intimate the present rate of property tax levied on Annual Rental Value in Belgaum City Corporation. In reply, the Assistant Commission (Revenue) vide their letter No. MNB/KS/DCB/A.T/2018-19/2429 dated 16-02-2019 has intimated that as per Govt. Order, the City Corporation of Belgaum has implemented methodology of Self Declared Assessment with effect from 2002-03 and they are not collecting the property tax as per old methodology of assessment based on ARV.

In the said reply it was also mentioned that as this office has received the written information regarding the methodology of self declared assessment of City Corporation of Belagavi on 16-02-2019 and presently there is no comparison of rates of property tax between the neighbouring corporation and the Cantt. Board, the procedure for revision of rate of property tax as required under Section 66 of the Cantonments Act 2006 will be implemented.

Based on this reply, the audit authority has been requested to settle the objection. However, the said objection was not settled and the Director of Audit, Defence Service vide their letter No. 1299/Samanvay/W/PNA/20/2019-20 dated 21-02-2020 has directed this office to provide the further progress on the revision of property tax.

It is further submitted that the ARV only the revision of tax rates i.e, 22% of the ARV does not increase the amount of property tax collected by the Cantonment Board Belgaum. The ARV is fixed afresh during Triennial Revision of Assessment list . The Cantonment Board Belgaum during every Triennial Revision of Assessment list has considered the increased whatsoever in rents and fair letting value and has facted the same while revising the property tax during every triennial revision of assessment list. Moreover, the property tax has been increased by 155% during the Triennial Revision of Assessment for the year 2019-2022 comparison to previous triennial revision of assessment for the year 2016-2019. And the further increase of 196.82% compare to the year 2022-2025. In the present circumstances, the tax revenue of the Board has been increased significantly.

Further the Board is levying conservancy tax @10% on ARV which is included in Consolidated tax and hence separate drainage tax, tree tax and education tax is not levied separately. Therefore the matter is brought before the Board for discussion and to take further dicision in the matter.

Report of the Revenue Supdt. along with relevant documents are placed on the table.

RESOLUTION No. 25

The Chief Executive Officer explained to the Board that the Cantonment Board is required to follow the local municipal tax rates prevailing in the nearby municipal corporation. Prior to 2002-03, the property tax rate of the neighboring city corporation was 20% of the Annual Letting Value. Therefore, the rates were not increased from 1992 onwards, as the rates set by this Board (22% on the ARV of the property) were already higher than those of the Belgaum City Corporation.

The CEO further informed the Board that though the rates of taxes not revised, there has been an increase in tax revenue in every Triennial Revision of Assessment. For instance, property tax increased by 155% during the 2019-2022 Triennial Revision compared to the 2016-2019 period. Furthermore, there was an additional increase of 196.82% in the 2022-2025 assessment period. In the present circumstances, the Board's tax revenue has increased significantly.

After detailed discussions, the Board unanimously resolved that the presently the revision of tax rate does not need to be revised, as it is already on the higher side.

Regarding revision of water charges rates of domestic use in Belgaum Cantonment Area

Ref: Audit Memo No. 14 dated 13-01-2020 received from the Sr. Audit Officer, Defence Services, Pune

An Audit Memo No.14 dated 13-01-2020 has been received to this office from the Sr. Audit Officer, Defence Services, Pune regarding non installation of water meter and under recovery of water charges amounting to Rs. 3.47 crores (approx) resulting in extra burden to the Board. In this regard it is stated that during the audit period carried out by the officials of the CAG authority, it was observed by the Sr. Audit Officer that there is wide difference between the amount of water charges paid to KUWS&D Board and that recovered from the Cantonment Board. Thus the said matter has been brought before the Board in the year 2021.

As per norms, Cantonment Board has to follow the rates of the adjacent Municipal Corporation. However the Board has not revised the charges at par with the neighbouring City Corporation of Belagavi and thus the Board has incurred a huge amount of loss due to levying of lower rate of water charges being collected from the consumers of the Cantonment Board Belgaum and the Audit authorities have also suggested to fix the water charges at the rate on which the Board is buying from the KUWS& D Board. It was also pointed by the Audit Authorities that the Cantonment Board has not installed the water meters so far for the water supply connections provided in Cantonment Area.

Further it was also mentioned that the water for other than drinking purpose in the Cantonment Board jurisdiction is managed through 25 bore wells and 21 open wells fitted with pumps and water tanks. The yield of water from these bore wells/open wells has not been calculated/arrived by the Board. Therefore the audit authority has suggested/opined to arrive the same and intimate to the audit. The audit authority has also opined in the audit to fix water meter to each water supply connection so that the water will not be wasted and the residents/commercial establishments will pay the water charges on the actual water utilized by them.

As per the Govt. of Karnataka Order No. NAE 07 UWS 2011 Bangaluru dated 20-07-2011, the flat rate of water supply charges for domestic use is Rs.2500/-p.a. Therefore it was proposed to revise the rates of water supply charges of domestic use which is given below. The water charges rates for other categories such as Non Domestic, Semi Commercial and Commercial were not proposed to revise since the said rates were quite reasonable :-

The Board considered the matter in detail and vide CBR No. 11 dated 19th March 2021 resolved to revise the rates in respect of water connection for domestic use w.e.f. 01/04/2021 as follows :-

It was also resolved that the matter of water charges to be levied on the water supplied through open wells, bore wells, the matter may be brought before the board after detailed survy of the persons using the water.

Accordingly the matter has been brought before the Board who considered the matter and vide CBR No.43 dated 15/07/2024 has fixed charges for using ground water for commercial, residential and other purposes.

Now the matter is again brought before the Board to revise the charges of drinking water supply to the consumers of the Cantonment Area at par with the City Corporation of Belagavi since still there is huge revenue loss between purchasing of treated drinking water charges from KUIDFC/L&T Authorities and amount recovered from the consumers of Belgaum Cantonment Area. The proposed rates are as under :-

Report of Assistant Engineer and Revenue Supdt. alongwith relevant documents are placed on the table. RESOLUTION No. 26

The CEO apprised the Board that during the CAG Audit of 2020, the Senior Audit Officer observed a significant difference between the amount of water charges paid to the KUWS&D Board and the amount recovered from the Cantonment Board. This matter was brought before the Board in 2021, and it was proposed to revise the water charges to Rs.2,500 per annum, aligning them with the rates of the neighboring municipal corporation. However, at that time, the water charges were only revised from Rs.1,200 to Rs.1,500 per annum for $\frac{1}{2}$ " domestic use.

The CEO further informed the Board that the Cantonment Board is currently paying ₹12,90,000 per month to KUIDFC/L&T and HESCOM for the purchase of water, whereas the Board is recovering only approximately ₹1,88,000 per month from the residents of the Belgaum Cantonment Area. This results in an annual shortfall of ₹1,32,24,000. Therefore, a revision of water charges is necessary to reduce the financial loss.

The Board also discussed the matter of installation of meter to the drinking water supply connections, open well/bore well connections. And it is found that there is huge expenditure involved in installing the meters and there are always chances of breaking/damaging the meters which will result into non-recovery of charges as per recorded readings of the meter. Considering these points, the City Corporation of Belagavi has fixed flat charges to recover the water supply charges from the consumers of City Corporation of Belagavi. Further, considering the present financial position of the Belgaum Cantonment Board, it is resolved that presently, not to install the meters since the majority of the water supply connections are situated in Civil Area.

The nominated member expressed concerns that while some areas in the neighboring municipality receive a 24x7 water supply, the Belgaum Cantonment Area receives water only twice or thrice a week. As such, the proposed rates may be on the higher side. It was also discussed that the water pressure is very low, hence in some areas people are not getting sufficient drinking water. After taking into consideration all these aspects, the Board decided to revise the water charges fees from Rs. 1500/- to Rs.1800/- p.a. for $\frac{1}{2}$ " and charges for remaining sizes of bores shall be revised as proposed w.e.f 01.04.2025.

With the permission of the Chairperson, the following supplementary agenda was taken up AGENDA No.27

Regarding cancellation of termination of lease hold rights in respect of shop No.G-3, Grocery Market, Belgaum Cantonment.

Ref : Circular Agenda No.2 dt.07/08/2024 & CBR No.11 dt.25/09/2024.

The Board vide Circular Agenda No.2 dt.07/08/2024 which was got noted in monthly Board meeting vide CBR No.11 dt.25/09/2024 has terminated the lease hold rights of ibid shop, allotted to Mr. Irfan I Shaikh with the forfeiture of entire security deposit for non payment of monthly fees. The Board further resolved that eviction proceedings be initiated to evict the lessee from the premises and to file recovery suit under Sec.324 of the Cantonments Act 2006 to recover the outstanding dues.

The decision of the Board has been communicated to Mr. Irfan I Shaikh vide this office letter

No. Grocery Market/G-3/1731 dt.25/09/2024 and he has been directed to handover the above mentioned premises within a period of 15 days from the receipt of the letter. Beside, as per the CBR, the permanent security deposit amounting to Rs.24,000/- paid by him has been forfeited vide TR No.7 dt.20/08/2024.

In reply, Mr. Irfan I Shaikh vide his letter dated 21/10/2024 has submitted that he has been facing financial difficulties since the COVID-19 pandemic. Due to these challenges, his business has been struggling, and he has been unable to make timely payments of the monthly fees. He has also submitted that he has cleared all dues up to September 2024 and has requested that the termination be cancelled, allowing him to continue his business. Additionally, he has assured that he will make payments by the 10th of each month.

In response, this office, vide letter No. Grocery Market/G-3/2032 dt.04/11/2024 informed to Mr. Irfan I Shaikh that his request for the cancellation of the lease termination would only be considered upon payment of three months' advance license fees (including GST), totaling Rs. 20,710/-, with subsequent monthly payments to be made in advance. Mr. Irfan Shaikh has cleared the monthly fees till 31/01/2025.

It is also brought to the kind notice of the Board that there are a total 18 shops in the Grocery Market, of which presently 9 shops are vacant. In order to mitigate financial losses for the Board, it may be considered to allow Mr. Irfan I Shaikh to continue his business on a monthly fee basis till the actual date of expiry of the lease hold rights upto 26/10/2025 subject to condition that he will pay the monthly fees regularly and permanent security deposited which has already been forfeited will not be refunded to him. The Board may consider and take suitable decision in this regard.

Report of Revenue Supdt. & all concerned files alongwith letter u/ref, are placed on the table.

RESOLUTION No. 27

Considering that the lessee has cleared the dues, the Board's resolution regarding the termination of leasehold rights for the aforementioned shop is hereby cancelled. The lessee is permitted to continue his business on a monthly fee basis until the leasehold rights expire on 26/10/2025, subject to the condition that the monthly fees are paid regularly. Additionally, the permanent security deposit, which has already been forfeited, will not be refunded.

The following points is also brought to the kind notice of the Board :-

(a) <u>Sulabh Shouchalaya public toilet blocks (H-37) at GLR Sy.No.324/1, near Cattle Market</u>, Belgaum Cantonment

The Sulabh Shouchalaya public toilets, measuring 889 sq. ft., are situated on GLR Sy. No. 324/1, Belgaum Cantonment. The Board vide Circular Agenda No.1, dated 02/12/2024 reduced the base price from Rs. 5000/- to 3000/- per month. Despiting the reducing base price, no tenders are received for the said premises. Some parties are shown interest @Rs. 2000/- stating that due to shifting of Wholesale Vegetable Market, the number of consumers are declined drastically. Also they have to pay the GST, labour payment and cost of sanitary materials. Due to these reasons, it is proposed that the base price of the ibid premises be again brought down from Rs.3000/- to Rs.2000/-.

(b) Shop No. O-5 & O-6, Shopping Complex in Office Compound

Tenders have been called for Shop Nos. O-1,O-5 & O-6 in Shopping Complex at Office Compound, Belgaum Cantonment with the base price @ Rs.5500/-, Rs. 8500/-and Rs. 12500/- respectively. The bid received in respect Shop No. O-1 is above base price. Bid received in respect of Shop No. O-5 is below base price i.e, Rs. 5000/-. Hence the said bid may be rejected. For shop No. O-6, bid is not received.

Further it is submitted that these shops are located at the backside of the complex, making them less visible to the public, which impacts business viability. Shop No. O-5 is located near a toilet, which may deter potential bidders. Feedback from existing lessees suggests that the base prices are on the higher side considering the low commercial activity in the area. Many of the backside shops are currently being used for storage rather than retail purposes.

Furthermore, these shops have remained vacant since 2021, leading to a loss of revenue for the Cantonment Board. Considering these facts it is proposed to reduce the base price from Rs. 8,500/- to 5,000/- in respect of Shop No. O-5 and Rs. 12,500/- to Rs. 6,500/- in respect of Shop No. O-6.

(c) Work shop Building H-14, Old Post office Road at GLR Sy. No. 251/6, Belgaum Cantonment

Work shop Building (H-14), admeasuring 682.8 Sq.ft. is situated on Old Post office Road at GLR Sy. No. 251/6, Belgaum Cantonment. Base price has been fixed @ Rs.14,025/- (which is last monthly fees received). This time, no tender is received for the same. In the year 2022-2023,

the base price was fixed @ Rs. 10,000/- and the bid was received @ Rs.12,750/-. It is therefore propose to reduce the base price from Rs.14,025/- to Rs.12,750/-.

The establishment of a Janaushadhi Kendra in government hospitals is of great significance due to the following reasons: Reasons for Establishment :

- a) To reduce the financial burden on the public by providing essential medicines at significantly lower costs (50-90% cheaper than branded medicines).
- b) To raise awareness and encourage the use of high-quality generic medicines as an alternative to expensive branded drugs.
- c) To enable economically weaker sections to afford necessary medications.

Following are the need for Establishment of Janaushadhi Kendra at Government Hospitals

- Many patients visiting government hospitals belong to low-income groups who may struggle to afford expensive branded medicines. The availability of a PMBJK ensures easy access to cost-effective alternatives.
- b) Since patients receive prescriptions at the hospital, having a Janaushadhi Kendra nearby allows them to purchase affordable medicines immediately.
- c) Government hospitals often face shortages of essential medicines. PMBJK can help bridge this gap by ensuring the availability of required medications.
- d) The Janaushadhi Kendra aligns with Ayushman Bharat and other health initiatives by making medicines more accessible to all.

In view of the above and to benefit the general public of the Cantonment area, it is required to establish a Pradhan Mantri Bhartiya Janaushadhi Kendra within the Cantonment Board General Hospital premises. The tenders may be called from the interested parties for establishing a Janaushadhi Kendra at the Cantonment General Hospital premises.

The matter is brought before the Board for consideration and to take suitable decision.

Fixation of fees/charges for Supply of Treated Wastewater

To consider the proposal for levying the fees/charges for the supply of treated wastewater from the wastewater treatment plant for gardening and other non-potable uses.

The main objectives of the Treated Wastewater are as follows:-

- Promote the reuse of treated wastewater to conserve fresh water.
- Ensure cost recovery and operational sustainability.
- Provide an affordable pricing structure for users, including government agencies, parks, and private consumers.

The Cantonment Board, Belgaum has taken the initiative of installation of decentralized STPs of capacity 100 KLD and 35 KLD for treatment of sewage water in order to use the grey water after treatment for other than domestic purpose and to avoid load on centralized STP. Accordingly, presently two Waste Water Treatment plant have been installed at Mutton Butcher Street at Sy. No. 251/751 and near Class IV Quarters, Old Post Office Road, GLR Sy. No. 251/847-A, Belgaum Cantonment.

The major benefits from this project are as under :-

- 1. To supply water for cleaning of Toilet Blocks, Beef Market, Mutton Market, Chicken Market, Fish Market, drains and Watering Gardens.
- 2. Save the pumping cost of ground water and to avoid depletion of ground water table.
- 3. To avoid sewage water contamination of Open/Bore wells.
- 4. To save transportation cost of sewage to centralized treatment plants and to save the surface water.

Apart from this the general public can also use this water for private gardening, parks and also other non-potable uses. For that the Board has to levy some fix charges for supply of wastewater. At present the Board is charging Rs.500/- per tanker for supply of ground water. Taking into consideration the Treatment Costs, Transportation Costs it is proposed to levy a fees/charges per tanker basis as follows:-

This initiative will support water conservation efforts, reduce dependency on groundwater and promote the sustainable use of treated wastewater for non-potable applications. The proposed fee structure ensures affordability while covering operational costs, benefiting both public institutions and private consumers. Board may consider and resolve accordingly.

Report of the Assistant Engineer & Revenue Supdt. alongwith all relevant documents is placed on the table

RESOLUTION No. 37

The Chief Executive Officer informed the Board that, at present, water supply issues are more. To address this, the Cantonment Board, Belgaum, has taken the initiative to install decentralized STPs with capacities of 100 KLD and 35 KLD for sewage water treatment. The treated grey water will be utilized for cleaning of Toilet Blocks, Beef Market, Mutton Market, Chicken Market, Fish Market, drains and watering gardens.

Further, the CEO also informed the Board that in Camp area there are many bungalows which have large gardens and water is also needed for other non-potable uses, so the general public can also use this treated waste water by paying nominal fees to the Board.

In view of the above and after a detailed discussion, the Board unanimously approved the proposed rates as mentioned in the agenda, with the treated water to be used exclusively for gardening and cleaning purposes.

With the permission of the chair the following additional points were taken up for discussion

- i. The PCB informed the CEO to issue a letter to L&T Authorities to complete the work of re-carpeting portion of roads where pipeline is laid by them within 3 months, failing which the work shall be taken up by the Cantonment Board from the Security Deposit amount which is lying in the Cantonment Board, Belgaum.
- ii. The Nominated Member informed the Board that while the road name changes have been done but some nameplates still display the old names. He suggested the Board to update these nameplates accordingly. In response, the CEO informed the Board that the process has already been initiated, and the nameplates will be updated as early as possible.
- iii. The Nominated Member raised the issue of pending bills of M/s. Dilipkumar Raijade. The AE informed the Board that the works were carried out for the visit of VVIPs during the XVIIth Post War Reunion. The works included the painting of gazebos and cast iron decorative poles, as well as repairs to streetlights and decorative poles on Thimayya Road, Belgaum. These works were executed by M/s. Dilipkumar Raijade, Contractor.

The CEO informed the PCB that these works were carried out by the contractor during the tenure of the late Shri K. Anand, the then CEO of the Cantonment Board, Belgaum. As a result, the payment has not yet been released.

In response, the PCB stated that the works were undertaken on an urgent basis for the Post War Reunion, considering the visit of VVIP army personnel during my tenure. Therefore, the payment of pending bills pertaining to the said works may be released.
