CONDITIONS OF AUCTION TO BE HELD ON 12.08.2025 IN RESPECT OF SALE OF THE OLD VEHICLE ON "AS-IS-WHERE-IS" BASIS AS PER PUBLIC AUCTION NOTICE NO. 8/Acct/43/SK/819 dated 18.07.2025

- 1. Any person related to the bidders who is in any way indebted to the Board or owes any money on any account whatsoever to the Board, is expressly prohibited from participating in this auction process.
- 2. The bidder has to submit (1) Residential Proof (2) Identity Proof (3) PAN Card & (4) GST registration Certificate (If registered)
- 3. The near/blood relatives of the members and the employee of the Cantonment Board Belgaum are not entitled to offer their bids.
- 4. A father/mother and his/her son(s)/daughter(s) OR relatives by blood or marriage, who have business dealing with one another, will not be allowed to participate in auction. A breach of this condition shall render two or more such bids disqualified.
- 5. The bid will be rejected straightway without assigning any reasons if the bidder is involved in criminal case, pending or contemplated against the bidder, OR if he/she has been blacklisted by any Government/Semi Government Department/Agencies/Cantonment Boards/ etc.
- 6. Person desiring to bid/participate in the auction will be required to pay an E.M.D. as mentioned below by self generated challan through eChhawani portal which will be interest free. The bidder should offer his/her bid above the base price as fixed by the Board. The Details of an E.M.D. and base price fixed for the following vehicles is given below:-

7. The bidders should raise the bid amount by at least Rs. 1000/-.

8. The EMDs of the bidders is interest-free in nature and as such the unsuccessful bidders cannot claim any interest on their EMDs. The EMDs of the unsuccessful bidders shall be returned to them after the completion of the auction process and upon application from such unsuccessful bidders. The applicant shall enclose a copy of EMD receipt, Bank Account details along with application.

- 9. The vehicles is being sold on "AS IS WHERE IS" basis in one lot. Vehicles can be inspected at the Cantonment Board office premises during working hours on any working day from 24.07.2025 to 31.07.2025. No guarantee or warranty is given as to the condition of the vehicle or its fitness for any particular purpose. No complaint or claim will be entertained after the sale regarding the condition of the vehicle
- 10. All bids shall remain valid for a minimum of **90 days** from the date of closing of auction unless otherwise specified.
- 11. Cantonment Board reserves the right to reject any or all offers without assigning any reason thereof at any time. No bidder shall have any cause of action or any claim against the board for rejection of its bids. The decision of rejecting the bids taken by Cantonment Board shall not be challenged in any proceedings. The officer supervising auction may close any bid which is considered unreasonable.
- 12. The successful bidder will be intimated after finalization of auction proceedings, calling upon them to deposit the quoted amount within the period stipulated by Cantonment Board. Failure on their part to deposit the quoted amount within the stipulated time will be entailed forfeiture of their EMD without any further reference / notice to them and the Old Vehicle would be resold by this office at its discretion.
- 13. The successful bidder will be responsible to remove the auctioned old vehicles within 15 days of deposit of the full quoted price. Delay beyond this period will attract fine @ ₹ 500/- per day or the sale may be cancelled and the E.M.D. will be forfeited. The successful bidder should make their own arrangements at their costs and risks to transfer the auctioned old vehicles during office working hours, after the approval of the Board. During force majeure, the decision of the Cantonment Board is final and binding.
- 14. In case the successful bidder fails to make payment or take delivery within the stipulated time, the bid may be cancelled and the EMD forfeited. The bidder may also be blacklisted from future sales.
- 15. Any missing items like stereo, jack, spare tyre, etc., will not be the responsibility of the licensor. The vehicle will be handed over in its current condition.
- 16. No road trial or starting of the vehicle will be permitted during inspection or auction. Once the vehicle is handed over, the office shall not be responsible for any accident, misuse, or legal complications thereafter.
- 17. No successful bidder will be allowed to touch, remove or interfere with the vehicle after bidding until full payment is made and delivery is issued.
- 18. All taxes/duties, including GST, if applicable, shall be borne by the successful bidder.
- 19. Once the sale is completed, no communication regarding return, refund, or replacement shall be entertained.

- 20. There will be no negotiations to reduce / deduct the quoted amount in any condition.
- 21. The successful bidder shall not damage the office property while removing / lifting the auctioned old vehicles. If the bidder cause any damage to the property, he / they shall liable to pay the damage as fixed by the authority.
- 22. The successful bidder is bound by these terms and conditions legally. In the event of breach of any of these terms and conditions, the Chief Executive Officer of the Board may impose penalty as he deems fit for every breach.
- 23. In case of any dispute arising out of the auction between the successful bidder and the Cantonment Board, decision of the Board will be final.
