

1. A bidding fee of Rs. 500/- through e- Chhawani (Non-refundable) has to be submitted by all bidder. Successful bidder shall submit 25% of the bid amount as EMD which shall be adjusted in the payment of value of auctioned and of Building Materials.
2. The Highest bidder shall ensure that no damage of any property belonging to Govt. or private, owner, fencing, drainage and pipe lines etc. will cause during the removal of Building materials. Successful bidder will be responsible to make good the damage caused if any.
3. The description and particulars of Building materials shall be deemed to be correct and if any error shall be found therein the same shall not annul the sale or shall any compensation be allowed in respect thereof.
4. The highest bidder shall be required to remove the Building Materials within 03 days from the date of issue of Permission for removal. Failure of which may result in penalty of 1000 Rs. /day.
5. The removal of Building Materials should be completed within stipulated period. If the highest bidder however fails to remove the building materials sold within time, the Cantonment Belagavi or its rep shall be at liberty to proceed with another/auction with or without notice to the highest bidder present at the auction.

6. The Cantonment Board, Belagavi or its rep reserves the right to refuse or accept the highest bids without assigning any reasons.
7. The removed Building Materials notified above for public auction will be shown on 21/04/2026 16:00 hrs. by the rep of this office to the bidders who are interested to bid in the auction.
8. The successful bidder shall deposit an additional 18% GST, applicable at the time of disposal of scrap materials, on the quoted amount
9. The successful bidder, if found removing any other building materials other than the auctioned one, shall be liable for prosecution, his amount will also be forfeited and the cost of illicit materials will be recovered from him as assessed by the undersigned.
10. The bidder have to submit the following documents:

11. The near/ blood relatives of the members and the employee of the Cantonment Board are not entitled to offer their tender.
12. The bidder should thoroughly satisfy themselves with regard to quality and condition of the scrap materials before participating in the auction. No complaints of any sort whatsoever will be entertained afterwards in this regard while taking delivery or thereafter.
13. Within 3 days of the declaration of highest bid the successful bidder should submit an undertaking that he/she will deposit entire amount at a time through e-Chhawani portal in the event of their offer is accepted by the Cantonment Board Belagavi in the prescribed format.
